## PREFERENCE DATE SYSTEM

(0)-DATE: This date can only be attained if the Race office has received a horse's foal papers with tattoo and valid negative coggins by February 24, 2010.

Please have coggins test good for entire meet.

### TWO YEAR OLDS 0-DATE EXTENSION:

All two year olds must have a tattoo, negative coggins, and original papers on file by March 2, 2010 to receive a 0-Date.

E-DATE: Papers turned in after February 24, 2010 will receive an E-date corresponding to the date the papers are turned in.

R-DATE: This date will correspond to the day of a horse's most recent race at Manor Downs.

1. Preference dates will not supersede the conditions of a race.
2. Preference dates are good for any type of race or distance with the exception of Stakes and Handicaps and Trials.
3. Preference dates shall be claimed at time of entry. In all cases the best preference date shall be preferred.
4. A Zero (0) Date has first preference, in cases where entry (E) and running (R) dates are the same, the horse with the entry (E) date shall be preferred.
5. Horses which are drawn into the body of a race will receive a running date corresponding to the date on which they are to run and will lose all dates previously held. This applies to all races with the exception of Trials.
6. Horses placed on the veterinarian's list, steward's list, paddock, or starter's list after it has raced will retain its preference date and will receive an R date corresponding to the race date in which they ran when taken off the list.
7. Horses entered into and taken out of a race due to a scratch will keep the preference date as if they had raced. Unless placed on a list, (i.e. stewards, paddock, starter, etc.) then they will receive an (R) Date corresponding to the Race Date in which they are removed from list.
- 8. Horses with established dates will lose that preference if the papers are withdrawn from the Racing Office for any reason including the intent to race elsewhere, stakes engagement, tattoo etc. and will receive a new preference date when the papers are re-submitted to the race office. The Racing Secretary may determine the status of any preference date established.**
- 9. Horses with established dates will not lose the preference date for a change of trainers or owners during the current meet.**
10. There are no special preference dates for Texas-Bred horses in overnight races. Any discrepancy pertaining to preference dates must be reported to the Racing Secretary. Winners are preferred in all winners' races. No horse may start to the exclusion of a single entry in any overnight race. Horses which are duel registered (AQHA-APHA) must declare which breed they will participate during the meeting.

## The Horsemen's Bookkeeper, Inc.

In the State of Texas the horsemen's bookkeeping system is centralized by the Texas Horsemen's Partnership, in order to better serve the horsemen running at the numerous tracks throughout the state. It is now similar to branch banking. This means that any necessary account maintenance can be done from any racetrack running a live meet in the state and through the Texas Horsemen's Partnership's main office in Austin year round.

### Horsemen's Bookkeeper Requirements

**Prior to starting a race an owner must have on deposit with the Horsemen's Bookkeeper the amount required to cover all costs incurred in starting that horse.**

**Prior to putting in a claim for a horse the owner or their Designated Representative must insure that all funds incurred with claiming a horse are on deposit in said account.**

# ATTENTION HORSEMEN ENTRANCE REQUIREMENTS

## ENTRANCE TO MANOR DOWNS STABLE AREA EFFECTIVE 2010 MEET

Because of recent cases of Equine Piroplasmosis within Texas and the Southwestern United States, Manor Downs is establishing a critical tick disease control program.

There is no vaccine for Equine Piroplasmosis. To avoid spread of the disease and protect your horse, it is important to eliminate contact with ticks and to prevent the transfer of blood from one equine animal to another.

Please be advised that the discovery of the disease in your horse would result in lifetime quarantine.

### ALL HORSES ENTERING THE STABLE AREA OF MANOR DOWNS MUST BE ACCOMPANIED BY:

A Certificate of Veterinary Inspection (health certificate) dated no more than forty five (45) days prior to entrance to Manor Downs stable area. The Certificate of Inspection must include evidence of a negative EIA (Coggins) test within the past twelve (12) months.

## AND

A statement by the accredited veterinarian signing, "I personally inspected this animal and it does not display clinical signs of Equine Piroplasmosis and I inspected and treated for ticks with an approved synthetic pyrethroid spray product."

## OR

An original copy of negative Piroplasmosis cELISA test that has been performed since November 1, 2009. As of this date, the National Services Laboratory, Ames, Iowa, is the only approved laboratory for Equine Piroplasmosis testing.

## TERMS AND CONDITIONS

The Rules of Racing adopted by the Texas Racing Commission and Manor Downs govern all races run at Manor Downs. Entries to any stakes at Manor Downs are received only with the understanding that Management of this Association reserves the right to refuse said entries or transfer of any entry for any cause and without notice to the subscriber. No nomination or entry will be accepted without agreement to the following conditions: That all disputes, claims and objections arising out of the actual running of a race or with respect to interpretation of the conditions of any race shall be decided by the Stewards, or whom they appoint, and that their decision regarding any and all points shall be final.

Applicant recognizes the risks of the activities to be conducted at the Racetrack by or on behalf of applicant, the owners of the horses named in this application and all other persons for whom applicant is acting (applicant and such owners and other persons are collectively referred to as the "indemnifying parties"), and has determined that the facilities at the Racetrack are reasonably suited for all horse racing related activities to be conducted by or on behalf of any of such parties. Manor Downs, Inc. and its partners, officers, directors, agents, vendors, employees, contractors, visitors and licensees (collectively "MD") shall not be liable to any of the indemnifying parties or any of their employees, agents, invitees or visitors, or to any other person whomsoever, for any injury to persons or damage to property on the Racetrack premises or any adjacent area caused by the negligence or misconduct of any of the indemnifying parties, their employees, agents, invitees, visitors or any other person entering the Racetrack premises under express or implied invitation of any of the indemnifying parties, or arising out of the use of the Racetrack premises and facilities by any of the indemnifying parties. The indemnifying parties hereby agree to release MD from and to indemnify and hold MD harmless from any liability, loss, expense or claims (including reasonable attorneys' fees) arising out of such injury or damage. The indemnifying parties shall not be liable to MD or to any other person whomsoever entering the Racetrack premises under express or implied invitation of MD, for any injury to persons or damage to property on the Racetrack premises or any adjacent area caused by the negligence or misconduct of MD and MD agrees to release the indemnifying parties from and to indemnify and hold the indemnifying parties harmless from any liability, loss, expense or claims (including reasonable attorneys' fees) arising out of any such injury or damage. The foregoing release and indemnification provisions shall be construed in a manner consistent with the limitations set forth herein to be as broad and inclusive as permitted by the laws of the State of Texas.

## Androgenic-Anabolic Steroid Rule:

*Texas Racing Commission*

*Title 16, Part VIII*

*Chapter 319. Veterinary Practices and Drug Testing*

*Subchapter D. Drug Testing*

Sec. 319.364. Testing for Androgenic-Anabolic Steroids

(1) No androgenic-anabolic steroids shall be permitted in test sample collected from racing horses except for residues of the major metabolite of stanozolol, nandrolone, and the naturally occurring substances boldenone and testosterone at concentrations less than the indicated thresholds.

(2) Concentrations of these androgenic-anabolic steroids shall not exceed the following urine threshold concentrations for total (i.e., free drug or metabolite and drug or metabolite liberated from its conjugates):

(a) 16 $\beta$ -hydroxystanozolol (metabolite of stanozolol (Winstrol)) - 1 ng/ml in urine for all horses regardless of sex;

(b) Boldenone (Equipose® is the undeclyenate ester of boldenone) in male horses other than geldings - 15 ng/ml in urine. No boldenone shall be permitted in geldings or female horses.

(c) Nandrolone (Durabolin® is the phenylpropionate ester and Deca-Durabolin® is the decanoate ester)

(A) In geldings - 1 ng/ml in urine

(B) In fillies and mares - 1 ng/ml in urine

(d) Testosterone

(A) In geldings - 20 ng/ml in urine

(B) In fillies and mares - 55 ng/ml in urine

(3) Any other anabolic steroids are prohibited in racing horses.

(4) Post-race urine samples must have the sex of the horse identified to the laboratory.

(5) Any horse to which an anabolic steroid has been administered in order to assist in the recovery from an illness or injury may be placed on the veterinarian's list in order to monitor the concentration of the drug or metabolite in urine. After the concentration has fallen below the designated threshold for the administered androgenic-anabolic steroids, the horse is eligible to be removed from the list.

## Toe Grabs Rule:

*Texas Racing Commission*

*Title 16, Part VIII*

*Chapter 313. Officials and Rules of Horse Racing*

*Subchapter D. Running of the Race*

Sec. 313.426. Toe Grabs Prohibited

(a) A Thoroughbred or Arabian horse is ineligible to start in a race when it has shoes (racing plates) that have toe grabs with a height greater than two millimeters (0.07874 inches), bends, jar calks, stickers, or any other traction device on the front hooves.

(b) A Quarter Horse, Paint Horse, or Appaloosa is ineligible to start in a race when it has shoes (racing plates) that have toe grabs with a height greater than four millimeters (0.15748 inches), bends, jar calks, stickers, or any other traction device on the front hooves.

TXRC Penalty Guidelines for overage from 5.1 to 9.9 mcg/ml

1st Offense: (365 day period) = **Minimum \$250 fine**

2nd Offense: (365 day period) = **Minimum \$500 fine**

3rd Offense: (365 day period) = **Minimum \$1,000 fine & 15 day suspension**

TXRC Penalty Guidelines for all overages of 10 mcg and higher.

1st Offense: (365 day period) = **Minimum \$500 fine & Loss of Purse.**

**Exam Horse.**

2nd Offense: (365 day period) = **Minimum \$1,000 fine, Minimum 15-day suspension & Loss of Purse. If Same Horse, Vet List for 45 days.**

3rd Offense: (365 day period) = **Minimum \$2,500 fine, Minimum 30-day suspension, Loss of Purse, and Owner fined \$5,000. If same**

**horse, vet list 60 days.**

## Race Horse Age Restrictions:

\*\*A horse that is more than 12 years of age may not start in a parimutuel race, unless the horse has won a race during the 12-month period preceding the race in which the horse is to start.

\*\*At Manor Downs, there are no age limitations on maidens other than the condition of the race and the aforementioned 12-year-old rule.

## Workouts

- In order for a horse to receive an official work, the registration papers (or a copy) must be on file in the racing office.
- Horses that have not started in 45 days preceding a race must have one official workout. First time starters must have two workouts within 90 days and one must be within 45 days. First time starters must also be approved to start from the gates before the horse is eligible to enter.

- Quarter Horses, which are first time starters around the turn must have an official workout at a minimum of 660 yards within 45 days and must be approved by the clocker. Trainers must notify the clocker and Outrider prior to gaining approval around the turn.

## Ship-In Information & Veterinarian's Exams

- All horses must have a valid negative coggins test dated in the 12-month period of arriving at Manor Downs. Horses must also have a health certificate issued in the last 45 day period before the horse's arrival. Any trainers wishing to ship horses earlier than the scheduled race day must contact the Stall Superintendent before shipping.
- Vet Exams for all horses stabled on the grounds or shipping in will be conducted between 9:00 - 11:00 a.m. All horses on the Lasix program must be on the grounds at least five hours before post time for the scheduled race. A handler must remain with each ship-in horse(s) until the horse has been inspected by the Commission Veterinarian. The legs of each horse scheduled to race must be unbandaged and clean for prerace exams.

## Silks & Saddling Paddock:

\*\*House silks will be provided for all races at Manor Downs. If trainer wishes to use an owners' silks, the trainer must enter with the silks, and may only be worn in stakes races. Manor Downs will not be responsible for any damaged or lost silks.

\*\*Trainers are responsible to bring their own rubber channels to the saddling paddock.\*\*

## Naming of Jockeys:

\*All Jockeys must be named at the draw. Any horse that does not have a jockey named on, will have one selected by the stewards or their appointee.

## Scratches:

\*There is no Scratch Time. There will not be Also-Eligibles, you enter to run, and all scratches must be made by the order of the stewards.

## **ATTENTION HORSEMEN:**

### **Changes to the 2010 Stakes Book:**

**Manor Downs Distance Cup should read as \$50,000 Guaranteed Purse.**

**Tony Sanchez Memorial Mile should read as \$50,000 Guaranteed Purse.**

**Manor Downs Paints & Appaloosa Stakes has been canceled due to lack of entries.**

### **Allowance and Penalties:**

Owners and trainers must be careful to claim correct allowances at the time of entry, and are solely responsible if any horse starts with the wrong weight. Winners or non-winners of a stated sum means a winner or non-winner of a single race of that value to the winner. Only those past performances obtained from the AQHA, the Daily Racing Form, or Equibase will be recognized in determining allowances and eligibility. Substitute or extra races will not necessarily be used in the order posted.

### **TTA ACCREDITED TEXAS BRED PROGRAM:**

To encourage the breeding of horses in this state, any accredited Texas-Bred horse finishing first, second, or third in any race in Texas (other than a stakes race restricted to Accredited Texas Breds) may be eligible for owner, breeder, and/or stallion awards through the ATB incentive program. Funding for awards is derived from breakage and 1% of all multiple wagers at each racetrack, with each racetrack generating awards funds only for the horses racing at that track. From the total generated, awards funds separated into categories for eligible owners (40%), breeders (40%) and stallion owners (20%). Additionally, the first 25% of all awards generated is set aside for owner bonus awards, paid to owners of ATB horses finishing first, second, or third in open company races. The owner bonus is in addition to regular ATB owner awards. In this condition book, the acronym ATBOIA appearing in parenthesis in race conditions after the amount of the overnight purse stands for estimated Accredited-Texas-Bred Owner Incentive Awards. Owner incentive awards are not considered part of the purse, and therefore, are not subject to deductions for jockey fees. The amount of the estimated ATB owner incentive awards available for each race restricted to Accredited Texas-Breds will appear like the following example (Plus \$1,000 ATBOIA). The amount of estimated ATB owner incentive awards available for each open company race will appear like the following example (Plus up to \$1,000 ATBOIA). All ATB Incentive Program awards- owner bonus, owner, breeder, and stallion owner, will be paid by the Texas Thoroughbred Association approximately four weeks after the race meet has ended.

### **TQHA ACCREDITED TEXAS BRED PROGRAM:**

To encourage the breeding of horses in Texas, any Accredited Texas-Bred Racehorse finishing first, second or third in any Texas pari-mutuel race (except stakes races restricted to Accredited Texas-Bred horses) shall receive a purse supplement. Approx. \$1.5 million is distributed yearly through the Accredited Texas Bred Awards Program. According to the Texas Racing Act, on every racing day, an association (track) shall provide for the running of at least two races limited to Accredited Texas-Bred horses, one of which shall be restricted to maidens.

\_Benefits to 'Horse Owner': \*40 percent is allocated to the eligible owners of the Accredited Texas-Bred horses that finish first, second or third.

\_Benefits to 'Breeder': \*40 percent is allocated to the eligible breeders of the Accredited Texas-Bred horses that finish first, second or third.

\_Benefits to 'Stallion Owner': \*20 percent is allocated to the eligible owners of the Accredited Texas Stallions standing in this state at the time of conception whose Accredited Texas-Bred progeny finish first, second, or third.

## TEXAS RACING COMMISSION (TRC) LICENSING:

### Trainers:

1. All Trainers must be licensed prior to the entry procedure.
2. All Trainers must open a file with the Racing Office before any of his/hers Owners' licenses can be validated.
3. It is the Trainers' responsibility to keep the Texas Racing Commission licensing office current on their Owners' and employees' status. Failure to do so may result in disciplinary action by the stewards.
4. Whenever a Trainer terminates an employee, the licensing office should be notified. The license badge may be returned to the licensee if and when he/she is employed by another licensed Trainer.

### Owners:

### Owners:

1. All Owners, as listed on the horse's registration papers, must have a current license.
2. Owners' licenses will not be issued unless a licensed Trainer is named on his/her application.
3. If an Owner is unable to complete his/her application due to illness or absence, the licensed Trainer desiring to enter the horse may complete an emergency Owner's license for the absent Owner.
4. All Owners who lease horses for racing purposes are responsible for licensing both the Lessee and Lessor.
5. If the Owner is not an individual, each partner who has ownership interest of five percent (5%) or more must be licensed by the TRC.
6. A person may not be licensed as an Owner if the person is not the Owner of record of the properly registered race animal which the person intends to race in Texas which is in the care of a Trainer licensed by the TRC.

All Jockeys, Backside personnel and Employees of Manor Downs must be licensed by the TRC. New multi-year licenses are now available for jockeys, owners, trainers, and veterinarians. No nomination or entry will be accepted without agreement to the following conditions: That all disputes, claims and objections arising out of the actual running of a race or with respect to interpretation of the conditions of any race shall be decided by the Stewards, or whom they appoint, and that their decision regarding any and all points shall be final. All parties involved with entrants will agree to comply with the rules of the Texas Racing Commission and Manor Downs.

**All nominations and payments must be postmarked no later than the advertised due date. Any nominations or payments duly postmarked, but received later than ten days from the due date will not be accepted.**

You must notify the nomination secretary in writing to enable her/him to make stakes payments from your horsemen's account. Sustaining payments will not automatically be deducted. Nominations for Handicaps and ATOE payments must be in office at time stated. If you wish your payments to be deducted from your account you must make

arrangements for each payment with the **Horsemen's Bookkeeper and Nominations Secretary.**

Manor Downs reserves the right to divide this race, including both the added monies and all fees, in the event that there is a greater number of starters than the track can accommodate. In all stakes, entries must be made through the entry box by the usual time of closing unless otherwise specified. It is understood and agreed that entries are accepted with the understanding that the horse(s) entered will only be allowed to start if in good standing at the time of the actual running of the race. Manor Downs reserves the right to cancel this stakes race at any time prior to the actual running without liability, except for the refund of nomination and entrance fees if any. Late nominations will be accepted by payment of all nominating and sustaining payments due plus late payment penalty stated on Nomination Blank on or before the applicable due date.

The subscriber hereby assigns to Manor Downs any and all rights to photographs, motion pictures, television and radio broadcasts in connection with any race run at Manor Downs.

## TERMS AND CONDITIONS FOR ALL STAKES AND ELIMINATION TRIALS

A sufficient number of trial heats will be carded and run on the advertised dates. The number of trial heats run will be dictated by the number of entrants. In the event that ten or fewer horses pass the entry box for the trials no trials will be run. The final will be run on the advertised date.

The ten (10) fastest Quarter Horse and Paint qualifiers will be selected from the trials to compete in the final. In the event that 100 or more horses remain eligible and enter into the trials, an Invitational race will be carded. The Invitationals will be based on times with (11-20) qualifiers preferred and so forth. Preference will be given in order of fastest times recorded in the time trials. Invitationals will pay out five places, 1st =60%, 2nd=20%, 3rd= 11%, 4th= 6%, 5th= 3%. In the event that two or more time trial contestants have the same qualifying time and a tie exists a draw by lot will be conducted to determine eligibility to compete in the final. *(Except in the event that said entrants compete in the same trial heat and no dead heat exists the horse that finishes in the best position will automatically qualify.)*

**Should a malfunction occur with the electronic timer on any time trial, finalists from that time trial will then be determined by official hand times (1/100th, or .01 of a second) operated by three officials and disinterested persons. The average of the three hand times will be utilized for the winning time, unless one of the hand times is clearly incorrect. In such cases, the average of the two accurate hand times will be utilized for the winning time; other horses shall be given times according to the order and margins of finish with the aid of the photo finish, if available.**

In Thoroughbred trials, ten qualifiers will be determined by order of finish in trials. If necessary there will be a "shake" to determine the last finalist(s). No consolation race will be run. There will be no "also eligibles list". If a mechanical failure of the starting gate occurs, or if a horse is inadvertently left behind the gate when the field is dispatched during a trial and such horse is declared a non-starter by the Stewards, all nomination, entry, and starting fees shall be refunded. During the running of a final or consolation, said entrant(s) shall also be considered a non-starter and awarded last place purse money. If a heat is declared a non-race all horses in that race shall be declared non-starters and not be eligible for official times. All fees shall be refunded.

In Handicaps: If you are weighted in the top 10 and do not enter back you will lose your nomination fee. If you scratch after entering back you will forfeit your nomination fee and entry fee. Horses entering into and failing to draw in a Stakes or Handicap race will receive a refund of all nomination and entry fees, except where the conditions of the race state otherwise.

### Sec. 319.111. Bleeders and Furosemide Program.

(a) Diagnosis of EIPH.

A bleeder is a horse that experiences Exercise Induced Pulmonary Hemorrhage (EIPH). Except as otherwise provided by this subsection, the medical diagnosis of EIPH may be made only by a commission veterinarian or a veterinarian currently licensed by the Commission. If the first EIPH event experienced by a horse in another pari-mutuel racing jurisdiction, certification of the horse as a bleeder by that foreign jurisdiction will also constitute a first report of a diagnosed EIPH event for purposes of this section. A veterinarian who diagnoses an EIPH event in a horse participating in pari-mutuel racing in this state shall report the event to the commission veterinarian in a format prescribed by the executive secretary. On receipt of the first report of a diagnosed EIPH event for a horse, the commission veterinarian shall certify the horse as a bleeder.

(b) Admission to Furosemide Program.(1) A trainer may admit a horse to the furosemide program by stating at time of entry that the horse will compete with furosemide.(2) A horse that competed with furosemide in its most recent start out-of-state must compete on furosemide in Texas unless withdrawn from the furosemide program at time of entry. (3) An EIPH event experienced by a horse that is admitted to the furosemide program is deemed to be a second EIPH event for purposes of Subsection (g) of this section.

(c) Administration of Furosemide.

Furosemide shall be administered to a horse in the furosemide program not later than four hours before the published post time for the race the horse is entered to run. The furosemide must be administered intravenously by a veterinarian licensed by the Commission. The executive secretary shall periodically publish the permissible blood levels of furosemide in post-race specimens and shall post the levels at each licensed racetrack.

(d) Requirement to Use Furosemide.

A horse in the furosemide program in Texas must compete with furosemide until withdrawn from the program.

(e) Withdrawal from Furosemide Program.

To withdraw a horse from the furosemide, the trainer must state his/her intention to race the horse without furosemide at time of entry.

Withdrawal from the furosemide program does not prohibit a horse from subsequent readmission to the program in accordance with this section.

(f) Readmission to the Furosemide Program.

A horse may be readmitted to the furosemide program if:

(1) at least 60 days have elapsed since the horse was withdrawn from the program;

(2) the horse is required to compete with furosemide pursuant to subsection (a)(2) of this section; or

(3) the commission veterinarian diagnoses the horse with another EIPH event.

(g) Bleeders List.

(1) The commission veterinarian shall maintain a list of horses that have been certified as bleeders and a list of horses that have been admitted to the



(2) On receipt of a report of a diagnosed EIPH event, the commission veterinarian shall place the horse on the veterinarian's list. For the first diagnosed EIPH event, a horse shall be placed on the veterinarian's list and is ineligible to start in a race before the 12th day after the date of the EIPH event. For the second diagnosed EIPH event, a horse shall be placed on the veterinarian's list and is ineligible to start in a race before the 30th day after the date of the second EIPH event. For the third diagnosed EIPH event, a horse shall be placed on the veterinarian's list and is ineligible to start in a race before the 180th day after the date of the third EIPH event. For the fourth diagnosed EIPH event, a horse is barred from pari-mutuel racing in this state. A horse that has not had a diagnosed EIPH event for a period of 365 consecutive days is considered a non-bleeder for purposes of this paragraph. The report of a diagnosed EIPH event from any pari-mutuel jurisdiction which officially records EIPH events will be recognized as an EIPH event by the Commission.

(3) Notwithstanding the foregoing, if after reviewing a report of a diagnosed EIPH event the commission veterinarian determines additional days on the veterinarian's list are essential to the health and safety of the horse, the commission veterinarian may extend the number of days the horse is on the veterinarian's list. The commission veterinarian shall record the medical reasons for the additional days.

(h) Report by Veterinarian.

A veterinarian who administers furosemide to a horse that has been admitted to the furosemide program shall report the administration on a form prescribed by the Commission. A report made under this subsection must be filed with the test barn supervisor not later than one hour before post time for the first race of that day.

**Sec. 313.301. Eligibility to Claim.**

(a) Except as otherwise provided by this section, in a claiming race, each horse is subject to be claimed for its entered price by:

(1) a licensed owner or lessee or an authorized agent acting on behalf of the owner or lessee; or

(2) a person who has applied for an owner's license and has been granted approval by the stewards to make a claim.

(b) A claim may not be made directly or indirectly by an owner for his or her own horse.

**Sec. 313.302. Claim Procedure.**

(a) A steward or a designee of the stewards shall supervise the making of claims and ensure the accuracy of all claims made in a race.

(b) A claim must be made in writing on forms and in envelopes approved by the executive secretary. The form and envelope must be filled out completely and must be accurate in every detail. For purposes of this section, the name of the horse as it appears in the official program governs.

(c) The person making a claim is responsible for determining the sex of the horse.

(d) A claim must be time stamped with the official track time shown on the tote board and deposited in a locked box provided by the racing secretary not later than 15 minutes before post time of the race in which the horse being claimed is to start. A person may not place money or its equivalent in the claim box.

(e) Before the deadline for filing claims for a race, a person may not:

(1) open the box in which claims are deposited; or

(2) reveal information regarding the filing of a claim.

(f) After the deadline for filing claims for a race, a steward or a designee of the stewards shall open the box, examine the claims, and notify the stewards of all accurate claims. The steward or designee will then notify the horsemen's bookkeeper of the claims to determine whether the appropriate amount is on

deposit with the bookkeeper in accordance with this subchapter and to debit the claimant's account for the amount of the claim, plus all applicable fees. If more than one person enters a claim for a horse, a steward or a designee of the stewards shall determine the disposition of the horse by lot.

**Sec. 313.303. Effective Time of Claim.**

(a) A person who has a valid claim to a horse becomes the owner of the horse when the horse goes on to the racetrack for the race. This subsection applies regardless of whether the horse reaches the starting gate and regardless of subsequent injury to the horse during or after the race.

(b) On the day claimed, a claimed horse runs in the interest of and for the account of the owner from whom the horse was claimed.

**Sec. 313.304. Claim Irrevocable.**

(a) Except as otherwise provided by this section, a claim that is filed in accordance with this subchapter is irrevocable.

(b) If the stewards declare a claiming race a "no race", all claims for that race are invalid.

**Sec. 313.305. Amounts on Deposit.**

(a) To make a valid claim, a person must have on deposit with the horsemen's bookkeeper an amount equal to the amount of the claim, plus all transfer fees, in the form of cash, money order, certified check, or cashier's check.

(b) A person who files a claim may not exhaust the person's account with the horsemen's bookkeeper during the two-hour period after the claim was filed.

**Sec. 313.306. Transfer of Claimed Horse.**

(a) A horse that has been claimed in a claiming race shall be taken after the race to the area designated by the association for delivery to the claimant, unless the horse is designated for testing.

(b) A person may not refuse to deliver a claimed horse.

(c) The engagements of a claimed horse automatically transfer to the new owner. A claimed horse is ineligible for entry in a future race unless the entry is made on behalf of the new owner.

(d) A horse may not be delivered to a successful claimant without written authorization from a steward or a designee of the stewards.

**Sec. 313.307. Responsibility for Testing.**

The trainer losing a horse through a claim is nevertheless responsible for the results of any drug tests performed on specimens obtained from the horse. The trainer is responsible for the horse during the testing procedures and may not deliver the horse to the successful claimant in the test barn until the commission veterinarian informs the trainer or representative that all testing procedures are complete.

**Sec. 313.308. Restrictions on Subsequent Use.**

(a) A horse claimed in a claiming race in Texas:

(1) may not be sold or transferred, in whole or part, by any method other than a claiming race during the 30-day period after the initial claim; and

(2) is ineligible to start in a race at a race meeting other than the one at which it was claimed until the end of the race meeting at which the horse was claimed.

(b) A horse claimed in another state is subject to the eligibility requirements for claimed horses in effect at the time of the claim in the jurisdiction in which the horse was claimed.

**Sec. 313.309. Ineligible Entry.**

A person may not enter or allow to be entered in a claiming race a horse against which a claim, lien, or other security interest is outstanding unless, on entering the horse, the person submits written consent to the entry by the person holding the claim, lien, or other security interest.

**Sec. 313.310. Restrictions on Claims.**

(a) A horse that is claimed may not remain in the care or custody of the owner or trainer from whom the horse was claimed.

(b) A person may not claim more than one horse in a race nor submit more than one claim for a race. An authorized agent may not submit more than one claim in a race, regardless of the number of persons the agent represents. A trainer may not be listed as the trainer for a claimant on more than one claim in the same race.

(c) A person may not offer or agree to claim or refrain from claiming a horse. A person may not prevent or attempt to prevent another person from claiming a horse.

(d) A person may not prevent or attempt to prevent a horse from racing in a claiming race for the purpose of avoiding a claim.

(e) A protection claim is prohibited and a person making such a claim is subject to disciplinary action by the stewards.

**Sec. 313.312. Protests.**

(a) A person wishing to protest the claim of a horse must file the protest with the stewards not later than one hour after the stewards declared the race official.

**Sec. 313.314. Disclosure of Mare in Foal.**

(a) A person may enter a mare or filly that has been serviced in a claiming race, provided:

(1) the owner files with the racing secretary a certificate from a licensed veterinarian, dated no earlier than 40 days after the date the mare or filly was last serviced, that states the mare or filly is not pregnant; or

(2) before entering the mare or filly:

(A) full disclosure of the servicing of the mare or filly is on file with and posted in the office of the racing secretary;

(B) the owner files with the racing secretary a signed statement agreeing to deliver without cost to a successful claimant the valid stallion service certificate regarding the servicing of the mare or filly; and

(C) all payments due for the stallion service or for any resulting live foal are paid in full.

(b) A successful claimant of a mare or filly in a claiming race may file with the stewards, not more than 30 days after the date of the claim, a petition to rescind the claim if:

(1) the claimant learns the mare or filly is pregnant; and

(2) the owner has not complied with subsection (a) of this section.

# ATTENTION HORSEMEN ENTRANCE REQUIREMENTS

## ENTRANCE TO MANOR DOWNS STABLE AREA EFFECTIVE 2010 MEET

Because of recent cases of Equine Piroplasmiasis within Texas and the Southwestern United States, Manor Downs is establishing a critical tick disease control program.

There is no vaccine for Equine Piroplasmiasis. To avoid spread of the disease and protect your horse, it is important to eliminate contact with ticks and to prevent the transfer of blood from one equine animal to another.

Please be advised that the discovery of the disease in your horse would result in lifetime quarantine.

### **ALL HORSES ENTERING THE STABLE AREA OF MANOR DOWNS MUST BE ACCOMPANIED BY:**

A Certificate of Veterinary Inspection (health certificate) dated no more than forty five (45) days prior to entrance to Manor Downs stable area. The Certificate of Inspection must include evidence of a negative EIA (Coggins) test within the past twelve (12) months.

**AND**

A statement by the accredited veterinarian signing, "I personally inspected this animal and it does not display clinical signs of Equine Piroplasmiasis and I inspected and treated for ticks with an approved synthetic pyrethroid spray product."

**OR**

An original copy of negative Piroplasmiasis cELISA test that has been performed since November 1, 2009. As of this date, the National Services Laboratory, Ames, Iowa, is the only approved laboratory for Equine Piroplasmiasis testing.
